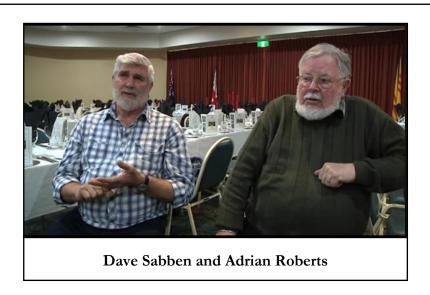

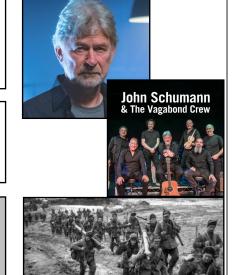

Understanding Indexation

(the head hurts)

Your Service and other veterans' pensions increase twice a year in line with increases in the cost of living and the average wage.

The Bureau of Statistics calculates how much cost of living has increased (CPI Index) and how much the average wage has increased. The Service Pension is increased using the greater of these two increases.

This process is known as 'indexation'.

Along with the Service Pension you get the Supplement. The Pension Supplement is an extra payment, paid on a fortnightly basis, to help with utility, phone, internet and medicine costs.

But here's the rub. Whilst the Service and other veterans' pensions are indexed to cost of living and wages, the Supplement is indexed only to increases in the cost of living.

This has not mattered in recent years because the cost of living has been increasing faster than wages. But that seems now to be reversing. It looks like increases in wages are overtaking increases in cost of living.

In years past, before the Covid event, wages increased by something like 4% annually while the cost of living increased by only about 2% annually. That may well be coming the norm again.

So we will see the Supplement increasing at a slower rate than the pensions they are attached to.

In other words, the Supplement will lose real value compared with the pension.

This simply does not make sense.

The Supplement should be indexed in the same way as the pension it accompanies.

Coordinated Veterans' Care (CVC) Program Evaluation Final report

The Department of Veterans' Affairs (DVA) engaged Abt Associates, in June 2023, to undertake an evaluation of the Coordinated Veterans' Care (CVC) Program. The evaluation was commissioned as part of a 2020-21 Budget measure which expanded access to the CVC Program for White Card holders with an accepted mental health condition.

The final report was recently published on the DVA website and may be of interest to our members. Findings from the evaluation will inform future improvements to primary care coordination arrangements for veterans. The report will also be provided to the Department of Prime Minister and Cabinet for further consideration in the context of the Government's response to Recommendation 72 of the Royal Consideration into Defence and Veteran Suicide Final Report.

The report is available for download at: https://www.dva.gov.au/documents-and-publications/cvc-program-evaluation-final-report, and is 84 pages in full.

Purpose of the Report

The Coordinated Veterans' Care (CVC) Program Evaluation Final Report assesses the effectiveness of the program in enhancing the health and wellbeing of Australian veterans. The Department of Veterans' Affairs (DVA) commissioned the evaluation to determine how well the program supports veterans with chronic conditions through coordinated care, self-management, and health literacy improvements. The report also examines the impact of expanding eligibility criteria in 2020-21 to include White Card holders with accepted mental health conditions.

Key Recommendations

- 1. Improve Patient-Reported Outcome Measures (PROMs) and Experience Measures (PREMs)
 - ♦ Enhance tracking of veterans' health improvements and satisfaction.
- 2. Refine Chronic Disease and Wellbeing Markers
 - ♦ Ensure comprehensive care by incorporating broader measures beyond clinical outcomes.
- 3. Redesign Program to Align with Changing Needs
 - ♦ Consider modifications to better suit evolving primary care policies and shifting veteran demographics.
- 4. Continue Program Refinement Based on Stakeholder Feedback
 - ♦ Incorporate insights from healthcare providers, veterans, and ex-service organizations.
- 5. Assess Cost Efficiency and Sustainability
 - ♦ Explore funding adjustments to optimize long-term financial viability.

These recommendations aim to ensure veterans receive proactive, coordinated care that adapts to their changing healthcare needs. We will continue to monitor DVA for any adoption of the recommendations and report outcomes as they come to fruition.

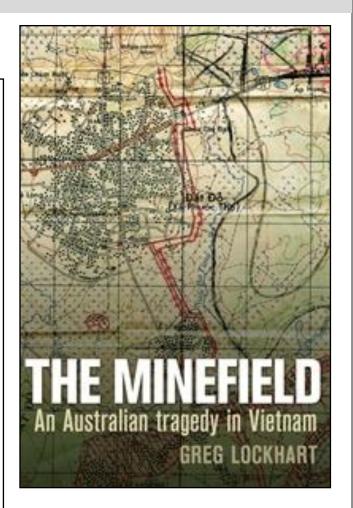
How could this disaster have happened?

Extract

Captain Paul Jones served in the Artillery Tactical Headquarters at Nui Dat in 1967:

By August-September 1967 there was a general concern around the HQ that mines were being lifted from the minefield. My understanding also was that Brigadier Graham shared the concern that mines were being lifted. I recall being asked to include likely approaches to the minefield in the Regiment's H&I program.'

A week or so before Graham relinquished command of 19 October, he told a journalist: 'Charlie may take some time to admit it, but he is virtually finished in Phuoc Tuy Province. He has lost the people and resources, and without these he cannot live.' The 1ATF H&I program powerful verification that these were anxiety driven last words. Despite the confident tone of his remarks, he knew what was happening in the minefield.'

John Schumann comes up with another great song.

Fishing Net in the Rain He describes the song as showing the human face of the Royal Commission into veteran suicide. Here is the song's press release.....

In 1982-3 John Schumann wrote and sang the Vietnam veterans' anthem, "I Was Only 19". Ostensibly, it was the story of Mick, Frankie and all the members of 3 Platoon, A Company, 6 RAR, but it was a song that spoke to every Vietnam veteran. 19's opening chords and emotive lyrics have the same impact today as they did when the song was released.

Now, 42 years on, Schumann speaks again about the human cost of war and military service. In the aftermath of the Royal Commission into Veteran Suicide, he found another story that needed to be told. When a devastated mother testified about the loss of her son, Schumann once again took one young man's experience to speak to a much wider issue.

Fishing Net in the Rain was written by Schumann (lyrics) in collaboration his friend & manager, Ivan Tanner (music). It tells the story one of the young sailors sent out by the Australian Government to "stop the boats".

"While the song was inspired by David Finney, it's really important to note that this song is about – and for - the thousands of current and former members of the ADF who have taken their own lives after serving Australia. And, perhaps more importantly, it's

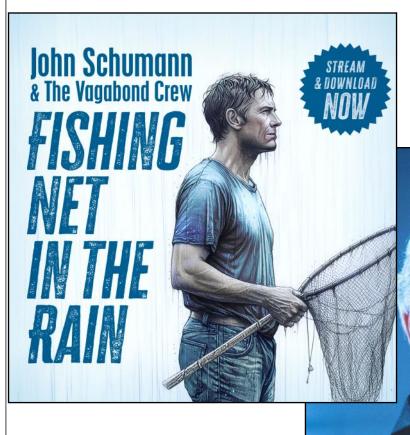
for their families," said Schumann.

A well-known advocate for veterans and their families, Schumann put words to Ivan Tanner's music to "bolt a human face" on to the recommendations of the Royal Commission. John Schumann knows a little bit about mental health and suicide. He spent 10 years giving mental health presentations in remote mining sites and construction camps in Western Australia and South Australia.

"Suicide is an immensely difficult and delicate topic. I'm no psychiatrist or psychologist but I know from my clinician friends that people don't want to end their lives. They just want the pain to stop," said Schumann.

Schumann understands that his name was put forward to be a Commissioner by a couple of politicians and some veterans' organisations, but his nomination was rejected by the then Prime Minister, Scott Morrison. Nonetheless, he followed the Commission with the idea of writing a song to shine a light on the tragedies.

In search of an entry point, John tracked down Julie-Ann Finney who, like Schumann, lives in Adelaide. She was one of the parents who campaigned for a Royal Commission, but would

she talk to him and share David's and her story?

"Julie-Ann knew of "19", I guess but after David died, she was going through his Spotify playlist and there I was - at the top of the list apparently," said Schumann. Julie-Ann shared David's diaries, notes, Facebook posts and blogs with John.

John said, "At one point, David was writing about his endless engagement with doctors and psychologists. He wrote in a Facebook post; 'Sometimes I feel like I'm catching all the answers, sometimes it's like holding a fishing net in the rain'.

"David's story is just one of thousands. But all Australians need to confront these stories and then demand that our political leaders continue to move forward on implementing the Royal Commission's recommendations.

"The run-up to the election is the perfect time to get politicians to commit to the recommendations in the spirit that they were written - rather than wordsmithed to death by bureaucrats in an attempt to make the implementations cheap and easy."

"We need to decide if 'Lest We Forget' are just words we say around Anzac Day or if they are a sacred promise that we, as a nation, keep in perpetuity regardless of cost and the passage of time.

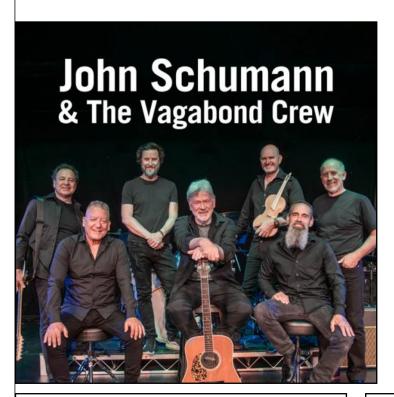

NEWS UPDATE

HERE WE CATCH UP ON NEWS FROM PREVIOUS ISSUES

RSL NSW AND THAT AGREEMENT

Following up on our article in the last Newsletter, about the RSL NSW Veterans' Support Fund (VSF). We are still in a negotiation phase, and although the RSL NSW has offered some lee way, we are yet to finalise any agreement, and as we go to print, we await a response to our request to them to meet with the Association in an effort to progress their proposal.

As reported in our last issue, based on the original proposal as offered by RSL NSW, to donate an amount of \$164,000 from the VSF, which is made up of monies collected from RSL NSW Sub-Branches who nominated this Association as the beneficiaries, we received a 27 page document in the form of a 'Partnership Agreement' to be signed off-on prior to any amounts being forwarded.

We could not, in all good faith, agree to some of the demands within the 'agreement', on behalf of the Association, and began a process of negotiating with RSL NSW, with several points of concern contained within the document. Some of our changes have been accepted by RSL NSW, however, there are still issues making it too demanding and onerous to accept and agree to.

We are hopeful that an agreement, satisfactory to both parties, should be reached soon, and both parties can deliver on mutual aspects to continue our endeavours to improve the wellbeing of all veterans and currently serving personnel in the ADF.

ABOUT OUR YEARLY RAFFLE

Ever wonder about our raffle and merchandise sales, and what happens to the funds we raise?

Our annual raffle and merchandise sales go a long way to enable the Association to continue with our Scholarships through AVCAT. To remind those of the scholarships VVPPAA NSW supports we advise that we fund 3 scholarships per year for 3 years, for an amount of \$4,000 per scholarship, or \$12,000 per year plus administration fees of around \$2,000 per year. AUSTRALIA'S INVOLVEMENT IN THE KOREAN WAR

We pause to reflect on the over 17,000 Australians who served during the Korean War, of which 340 were killed and over 1,216 wounded. A further 30 had become prisoners of war. This short essay does not include many of the actions by the RAN, RAAF and Army units, but honouring the brave men and women who fought in what became known by those who fought, 'The Forgotten War'. With 2025 marking the 75th Anniversary of the start Australia's involvement, we should reflect on those who made the supreme sacrifice in defence of democracy.

In the pre-dawn hours of 25 June 1950 the Korean People's Army (KPA) launched a massive offensive across the 38th Parallel into South Korea. They drove the Republic of South Korea's (ROK) forces down the peninsula, capturing the capital, Seoul, within a week. Within two days of the war's beginning, US navy and air force units were sent to aid South Korea. By the end of the month, US ground forces were deployed to the peninsula. The United Nations Security Council asked its members to assist in repelling the North Korean invasion.

Australia, with its commitment to the British Commonwealth Occupation Force in Japan, had two readily deployable RAN vessels, HMAS Shoalhaven and HMAS Bataan, as well as No. 77 Squadron, RAAF. It wasn't until 26 July that 3RAR was committed to ground operations in Korea, by which time 77 Squadron RAAF had been in action supporting ground troops since July 1950.

The Battle of Kapyong, where an Australian battalion and a Canadian battalion successfully defended their positions against a large Chinese force, is considered one of the most significant battles involving Australian troops in the Korean War. On 22 April, the Chinese launched their spring offensive, routing the South Korean 6th Division and driving them back down the Kapyong Valley.

The 27th Commonwealth Brigade advanced forward of the town of Kapyong. The 1st Battalion, Princess Patricia's Canadian Light Infantry, and 3RAR dug in on the high ground on either side of a seven-kilometre wide valley. The following day, the Chinese were engaged by the Australians and Canadians as well as a troop of US Army Sherman tanks and New Zealand Artillery.

Two nights and days of close fighting followed and on the evening of 24 April the Australians were forced to withdraw from their positions and, with the support of the Canadians and New Zealand artillery, fought their way down a ridge, rejoining the majority of the brigade in the Kapyong valley. The Chinese were stopped in their tracks and Seoul was saved from being attacked once more. The men of 3RAR suffered heavy casualties, with 32 killed, 53 wounded, and three taken prisoner. 3 RAR received a United States Distinguished Unit Citation for their actions at Kapyong.

In October 1951 3 RAR, along with British and Canadian forces, as part of Operation Commando, a large UN offensive against a Chinese salient, 3RAR advanced north of the Imjin River, attacking two key high points: hills 317 and 355. After five days of heavy fighting the Chinese were forced to withdraw off both objectives, and on repulsing several counter-attacks the men of 3RAR were firmly in control of Hill 355, known as Maryang San. The Australians suffered 20 men killed and a further 89 wounded during the fighting.

HMAS Sydney arrived in Korean waters in early October 1951, and began operations immediately. On board the carrier were three squadrons of the RAN Fleet Air Arm, Nos 805 and 808 squadrons, flying Hawker Sea Furies, and No. 817 Squadron, flying Fairey Firefly aircraft. The Sydney undertook numerous patrols in Korean waters during its deployment and its aircraft flew over 2,000 sorties, including ground attacks, artillery spotting, and escort missions. It incurred the loss of three crew and 13 aircraft. The Sydney returned to Australia in January 1952.

In April 1952, 1RAR arrived in Korea and joined 3RAR as part of the 28th Brigade. During its service, 1RAR took part in many patrols of noman's land and several operations against Chinese positions. The Australians' reputation for patrolling and raiding from both the First and Second World Wars was further enhanced by the efforts of the men of 1RAR and 3RAR during 1952. 1RAR was replaced by 2RAR in April 1953 and quickly established itself as a formidable patrolling and raiding force.

The last three days of the Korean War saw the Chinese mount one last offensive on Australian and US Marine positions in the Samichon Valley. The Chinese attacked in waves with heavy artillery support. However, the combined arms of the US and Commonwealth forces halted the Chinese attacks with heavy losses. This final battle cost 2RAR six killed and 24 wounded. The Marines suffered 43 killed and 316 wounded.

On 19 July an agreement for an armistice between the UN and the Communists was reached. The date for the signing was set for the 27th of July. The armistice was signed at 10 am on 27 July 1953. Sporadic fighting continued throughout the day, but as evening fell the guns fell silent. The armistice came into effect at 10 pm, ending three years, one month, and two days of war in Korea.

The end came so suddenly that some soldiers took some convincing that the fighting was really over. The former belligerent nations each withdrew two kilometres in accordance with the armistice agreement, forming the Demilitarized Zone which still exists today. Australian Forces remained in Korea as part of the multi-national peacekeeping force until 1957.

Lest we forget.



THAT DANGEROUS BACKLOG

If you go to the DVA website, Claim Processing Times, you will find the latest report on the backlog of veterans disability claims.

The backlog of veterans disability claims is, of course, the number of claims received by DVA but not yet finalised. That is, the number on which a determination has not yet been made.

You may also want to know how long claims are taking for receipt by DVA till determinations are made.

You might be interested in these statistics because waiting times for sick veterans have been unreasonably long posing a danger to some sick and troubled veterans.

Such is the importance of these statistics you will probably expect to find them at the beginning of DVA's report.

You will be disappointed.

You will find yourself swimming against a flood of irrelevant words and numbers, lame excuses and the attempted redefining of the word 'backlog'.

If you persist you will eventually succeed.

The report reveals seemingly reluctantly that;

As at 30 April 2025, DVA had 81,951 claims received but on which no decisions had been made ie the backlog.

And, waiting times remain unreasonably and dangerously long.

DVA defends itself, saying it is making progress and trying hard.

This may be so but the progress is snails' pace and the real damage was done in recent years when

VVFA was warning DVA in vain that the backlog was getting out of hand.

As younger veterans begin to age, history tells us that more and more will continue to bring claims to DVA because of their war caused torment, trauma, and disabilities. So it is likely the backlog will continue to climb. But there is a solution, which may be the only way to reduce the backlog and waiting times.

That solution is to cull the older claims,

unassessed and yet to be finalised, and rule them complete in favour of the claimants. Do this until the backlog is brought to a manageable number in the hundreds rather than multi-thousands Then start again not letting the backlog get out of control again.

Here's a more detailed plan.

We could arrive at a set of values for immediate actioning, that would have the desired effect of clearing the backlog, in a reasonable time, and free up more assessors to attend to more recent claims:

- Claims made prior to June 2020 assessed as complete and the claimants application ruled in favour of the claimants.
- Claims made from July 2021 to June 2023 with medico reports and imagery attached ruled in favour of the claimants.
- Claims made July 2021 to June 2023 without medico reports fast tracked for action within 90 days, or ruled in favour of the claimants.
- All claims made July 2023 to June 2024 be given a 90 day moratorium for completion and those with medico reports ruled in favour of the claimants. Those awaiting necessary reports and requiring further evidence be assessed and processed as a matter of

- urgency, and allowed a further 90 day completion target, before ruling in favour of the claimants.
- All claims made since July 2024 to June 2025
 be given 100 days maximum to clear those
 with required reports. Those claims made
 from July 2025 and current to have a 4
 month turnaround maximum, excepting
 where collecting medical evidence requires
 more time.

Such measures if enacted quickly should provide an immediate impact on veterans wait times, prevent possible suicide, and alleviate family stress, by giving the veterans a more realistic time frame in which to prepare their future.

With the advent of a new Veterans Entitlement charter just around the corner, in July 2026, and a change in training protocol from the Advocacy Training and Development Program (ADTD) requirement, to include Continuing Professional Development (CPD), now might be our only chance to clear backlogs in a more just, fairer and satisfactory manner for veterans and their families.

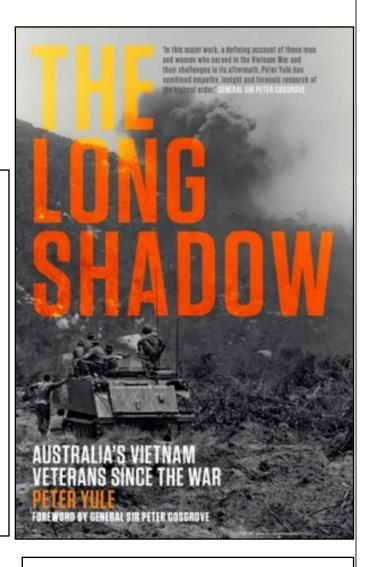

I write this email on two main topics that affect me the most. Health and Aged Care, and the expose' on the DVA delays and backlog.

I read most of the Newsletter in one sitting, then get back to veterans stories, the crossword, and those terrible jokes which keep me laughing, later, after I cool off from the hard issues.

What I find most irritating is the seemingly blind eye approach that DVA is oblivious to the dangers to veterans in delaying their claims for such long periods. What is the problem for a department supposedly put into place to assist veterans get fair and just compensation, for disabilities they receive when put in harms way by governments, willfully sending men and women off to fight their wars.

People don't purposely make claims willynilly and without due cause, unless they want to defraud governments. Veterans, in the main, have no reason to make unsubstantiated claims, so why they are repeatedly asked for several medical reports from medicos the veterans don't know, and have never been to for assessment. And, aren't the qualified advocates assisting veterans aware when someone is being untruthful.

And, aged care. It seems more and more that DVA is trying to reduce their budget by referring the sick and infirm veteran to other government departments responsible for civilian treatment. The excuse is sometimes said to be because other departments are more responsive to the frail and end-of-life respite care than DVA can achieve.

Article 14

The First Half of the Association's Initial Year

Part B - Parliament, the Media, Legal Activities etc

This article is the second of three outlining and commenting on events in the initial six months of the Vietnam Veterans Action Association (afterwards to be the Vietnam Veterans Association of Australia). It explains the importance of parliamentary support for the Association's agenda, examines the relationship between the early Association and the media, traces the origins of the call for a judicial inquiry and explores the Association's legal efforts before commenting on the coordination of Association activities, matters of strategy and funding.

The precise mechanics of Association parliamentary influence in the first half of 1980 are mostly unclear. However, mentions of the Association in questions and speeches by critics of the Government (and by Clyde Holding, in particular) point to liaison between those parliamentary critics and, variously, Association President Holt McMinn, Scientific Adviser John Evans and officials of at least the Victorian Branch. Parliamentary critics of the Government's handling of the Vietnam chemical issue who were not in frequent contact with Association figures in the first half-year had opportunities to meet with the organisation's representatives on at least two occasions at Parliament House and were doubtless encouraged to take up the cause by veteran constituents and local Association figures.

Factors other than the thrill of confrontation in the parliamentary chambers, made the wartime

chemical issue an attractive one for Opposition MPs and Senators to raise in an election year.

The feeling that Ministers were struggling to deal with an emotive, complex and occasionally technical issue – something best demonstrated by Defence Minister's Killen's mishandling of parliamentary questions about Agent Orange and affirmed by alleged Government unrest about ministerial performance on the chemical issue – was probably the most important of these factors. The fact that much of the media in this period took delight in the Government's difficulties with a wide range of issues, and happily publicised the worst Ministerial mis-steps (along with the roles of those revealing or precipitating them) would also have encouraged attacks in the parliament. Members and Senators attempting to expose ministerial and Government blunders knew, too, that their parliamentary efforts could yield a double dividend

because the media would follow through with discomforting ministerial interviews and irritating news stories.

The Association's

eagerness to keep the chemical matter before the public (and to help sympathetic

parliamentarians in their efforts to discredit related Government statements and actions) must also have encouraged Opposition figures to join the chemical fray in the first

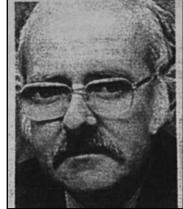
half of the year. And media stories about a wide range of chemical matters unrelated to either the Vietnam War or relevant events in the parliament would also have fostered coverage of the veteran aspect mostly playing out in the House of Representatives. In short, the broader chemical issue remained 'hot' for the first half of the year and interactions in the parliament over Vietnam War

chemical exposure probably stimulated the search for other chemical stories (in a vicious cycle of revelation, reproach and defensiveness).

The Association's efforts to support the pressure applied by Holding and others to Ministers and the Prime Minister in the House promised

more, though, than additional publicity for the Vietnam and broader chemical controversies. Those Association efforts and the resultant attacks constituted the best of available strategies for influencing key Ministers and the Government (and were

certainly a factor in the upscaling of

Government investigative efforts at the beginning of April). These efforts were important because, in the hierarchy of matters considered important by

parliamentarians themselves, performances in the chamber were ranked as more significant than any other. In 'the Canberra bubble' they were ranked as more significant even than ministers' performances on radio and television.

Consistent with this

view of the primacy of parliamentary performance, it was attacks on ministers and the PM over the Vietnam chemical issue – and especially those like Holding's, forcing the Government onto the back foot – that would exert more pressure to properly investigate and compensate harms than could be applied by external forces. As a consequence, the efforts by Holding and by the Association figures assisting him to change the Government's Vietnam chemical stance in the first half of 1980 were worth proceeding with, even if, as it turned out, they failed to result in significant change.

The Association and The Media

While Holding and others took the fight to the Government in the parliament, a small group of Association figures, added to pressure from outside.

John Evans, who as custodian of the Association's scientific knowledge had played an important function explaining the impact of chemicals in meetings with politicians and bureaucrats of various sorts, played an equally important part in the Association's media efforts. He didn't limit himself to a technical role, either, and was often interviewed by himself.

Meanwhile, Holt McMinn, whether in tandem with Evans or separately, pushed the Association agenda (rigorous investigation and appropriate compensation) in the media, outlining veterans' misfortunes, explaining what the

Association wanted the Federal Government to do and drawing attention to shortcomings in Government actions and pronouncements.

Bill McMillan, the Association's initial legal adviser, was also a willing media player: mostly by himself, and not restricting himself to strictly

legal issues. He featured in news stories with surprising frequency considering the restrictions on promotional activities by Australian solicitors in the early 1980s. McMillan would seem to have initiated stories to a greater extent than McMinn and Evans; in the absence of any early plan to guide the Association's persuasive efforts, the latter two would seem mostly have responded to media enquiries (and not initiated coverage).

In the early months of the year, Bernie Szapiel (Victoria), Jim Wares (NSW), John Harper (Queensland), Wendy Rowney (SA) and Mike Boland (ACT) were also frequently in news reports, encouraging attendance at Association meetings and in various ways furthering the cause of investigation and compensation. (These figures can be distinguished from the many veterans who helpfully assisted Association efforts by speaking to the media about their war and post-war experiences.)

It presumably took McMinn, as the most frequent spokesman in the first half of 1980, some time to understand how to get the best out of the media. Indeed, it is arguable that the sharp decline in media reports on Vietnam chemical matters in the final weeks of the half year was as much because of the Association's failure to appreciate the need for new story angles (to sustain media attention), as about other factors: especially the Parliament rising at the end of May.

Association media releases and press conferences were evidently rare in the early months of the year. McMinn and Evans' willingness, though, to engage with reporters and provide interesting content – often, in McMinn's case,

delivered with larrikin irreverence and ingenuity, and in Evans' case with an eye to disturbing scientific detail – meant that the Vietnam chemical issue had a profile which, buoyed by ongoing domestic and international chemical news stories, craved parliamentary attention for most of the half year.

In that period, Evans and McMinn, unlike in so many ways, often constituted a kind of double act: Evans, precise and unflappable, McMinn, more mercurial and prone to media-friendly outbursts – the former providing the scientific foundation for veterans' concerns (but not being afraid to dwell on the worst health outcomes) and the latter personalising veterans' problems and criticising

unsatisfactory official responses. As will be revealed in a future article, Evans would, in time, play a role far beyond the "scientific" or "educative" in determining McMinn's fate as National President and thereby facilitating the presidency of **Phil**

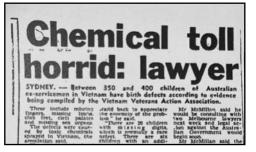
Thompson.

If the attacks on Ministers and the Government chronicled in the previous article in this series refute McMinn's and

others' later claims that the Association was without friends in this period, coverage of these attacks by the media also discount the argument.

The Association and the Call for a Judicial Inquiry

For both sets of supporters – in the parliament and in the media – the Association's arguments in favour of a public (later judicial) inquiry (during



which exploration of the impact of Vietnam defoliants could be presided over by a judge) were more readily understood than the complexities of defoliant science. Where did the idea of a judicial inquiry spring from?

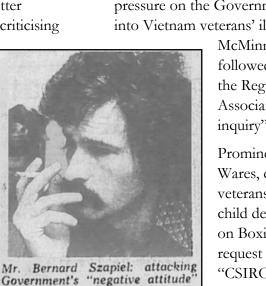
The December 1979 announcements by Bernie Szapiel and Holt McMinn that an association of Vietnam veterans was being formed had included, in the proposed organisation's goals, the requirement for the Government "to hold an inquiry", without specifying what type of inquiry was sought. Those announcements followed an observation by the RSL National President, William Keys, that there needed to be "a special examination of this chemical] problem conducted by the Veterans Affairs Department" and a peculiar report in The Australian that the Administrative Appeals Tribunal (a body charged with reviewing administrative decisions) was, following RSL pressure on the Government, to conduct an inquiry into Vietnam veterans' illnesses. The Szapiel and

McMinn announcements also followed a call by the ACT head of the Regular Defence Forces Association for "a full Federal inquiry".

Prominent NSW veteran Jim Wares, drawing attention to local veterans' health complaints and child deformities in The Australian on Boxing Day, foreshadowed a request for an investigation by a "CSIRO Committee drawing at least 30 per cent of its members

from independent medical practitioners from outside the Government".

The (less-specific) inquiry call was renewed by Szapiel and Wares in early January at the same time as veteran **Tim Fischer** (then a State MP) called for "an independent Australian study", and the Sunday arm of the Melbourne <u>Age</u> reported "calls from [mostly unnamed] medical experts and

politicians for an independent Australian study of the defoliant." Independence thus became an entrenched factor, and it was consequently no surprise that Minister Adermann's 7 January 1980 announcement of an investigation (with details to be provided later) was of an independent study (see

previous article and references to "The Institute study").

An RSL press release calling for a survey of Vietnam veterans, distributed on the day after the Minister's study announcement, contained no reference to independent conduct (or the desirability of such conduct), either in relation to its own survey or the Government-proposed study. The RSL's proposed survey (further commented upon in the next article in this series) was, as a preliminary activity, less in need of independent implementation and analysis than the study-proper, but the League's failure to push for true independence of the Government exercise was a telling omission: the League evidently saw no problem in Government conduct of the major activity.

The Minister's announcement of the Government study prompted Holt McMinn to urge

wide terms of reference and (true) independence "under the auspices of a body like the Academy of Science and jointly chaired by a scientist and a non-scientist". After a 12 January announcement by the Minister (which included information on the body to conduct the study) and comment by

the project head on proposed steps, McMinn was reported to be warily supportive. However, encouraged by newspaper descriptions of the study as "a Public Service inquiry", he was soon refocused on 'independence', requiring "a purely independent body to run this inquiry", before (a) describing the Government study as "an attempt to cover up ... [and] ... a cheap political ploy" and (b) stating, correctly, that it would "do little to establish a connection between the defoliant and medical claims".

A Victorian Liberal back bencher, Bill Burns, while welcoming the Government initiative, called soon after for "a thoroughly independent study" before proposing an investigation by a Joint Parliamentary Standing Committee, as people involved in the proposed study were "too tied in with government".

Public doubts about the usefulness of the Government study continued. Mike Boland repeated McMinn's claim about its limited utility; the chemical industry wanted major changes to the scope of the exercise; and the Australian Democrats indicated a lack of confidence by calling for a 10 year medical survey of veterans.

On 21 February, Clyde Holding criticised the Government for choosing a form of inquiry "which will exclude submissions from interested persons or organisations ... [and] ... which is under the control of the Minister". He stated that Vietnam veterans wanted "an open judicial inquiry". This mention of a judicial inquiry may have been just a casual re-phrasing of the Association's requirement for a public inquiry, but an Association Press statement, probably issued on the next day, picked up on the precise term, referring to "an Independent Judicial Inquiry". This brought to an end the Association's quasi-search for the precise form of its preferred investigation.

Two weeks later, after a meeting of VVAA representatives with the Minister for Veterans' Affairs in Canberra (discussed below) the specific requirement for a judicial inquiry again emerged. The VVAA attendees at the meeting had been



informed by the Minister that any changes they wanted made to the Government study needed to be put to DVA in writing; McMinn responded with a demand for a judicial inquiry.

McMinn and the relevant advisers might have been persuaded of the merits of a judicial inquiry by the conduct of notable late 1970s inquiries presided over by judges, the most notable of which was the NSW Royal Commission into Drug Trafficking (the Woodward Royal Commission, reporting, coincidentally, in late October 1979). However, the Fraser Government, wasn't the least averse to establishing Federal public inquiries, having appointed an astounding sixty-four of them between December 1975 and the end of 1979; these included various committees of review, committees of inquiry, plain reviews and Royal Commissions, to name just a few of the forms taken by these bodies. A good number were presided over by judges. The deliberations of some were well publicised but, most, owing to their obscure subject

matter, were only occasionally reported on. All provided the Association with a model of open scrutiny of a public problem. Perhaps the Toose Inquiry – commented upon in the very first article in this series, and a marathon example of the relevant activity – was also recalled by veterans and advisers.

More important, though, than speculation about who and where the idea of a judicial inquiry came from is what, procedurally, such an inquiry was thought to offer viz the previously referred to opportunity to proffer evidence on chemical matters, to contest contrary evidence, and to call and cross-examine witnesses ... all before an impartial judge.

The call for such an inquiry and the flipside of that call – condemnation of the Government alternative – were, in the absence of Government acceptance of Association-supported science, an important element of the attacks by Holding and others on Minister Adermann. Persuasive rejection of the Association's call for a judicial inquiry was the task before the Government ... and took up much of the third (31 March 1980) Ministerial Statement by Adermann on the chemical matter in the House.

Legal Activities

Writing about Association-related legal issues is challenging because Bill McMillan, the Association's initial legal adviser, was involved from a very early point in a wide range of activities. These included ones of an organisational nature and those best described as 'influencing', in addition to the furtherance of negligence actions in Australia and the US – actions in which the Association had a vital interest but to which it could not be a formal party. There were soon, too, other Australian lawyers assisting the Association, mostly with US (class) action matters, in addition to the American lawyers, led by Victor Yannacone, steering that class action. Still other lawyers – usually solicitors - were also organised to assist in minor criminal matters as part of State Branch welfare work.



McMillan made mention of a four-pronged (all fronts) possible legal strategy in his initial correspondence to McMinn but his focus would seem thereafter to have been mostly divided between negligence actions at home and abroad, noting that preparatory work for

these proceedings – especially in making connections between harms and (breached) legal duties – was going to be of potential help in pressuring the Government and pursuing positive outcomes in other forums, including repatriation tribunals. Work on these negligence actions was undertaken at some risk to McMillan, particularly because of the expenses associated with participation in US events, but such was the legal model in place and such was his willingness to proceed.

McMillan's Australian negligence actions

MacMillan was to act for two veterans and their families in negligence suits against the Federal Government and chemical companies (with the Association having, in all likelihood, connected the veterans with McMillan in the first place). Legal action was formally initiated for both families in the first half of 1980. As will be discussed in later articles, Government records indicate that neither of these suits were to benefit the plaintiff families or, perhaps, McMillan. However, if there had been different outcomes for the plaintiffs, other veterans in similar circumstances would have been able to follow the same legal path.

Associated with these two actions were McMillan's efforts to have the Government waive the protection potentially afforded it by the statute of limitations (which prevented legal action from being commenced after the passing of specific time periods ... with the precise periods varying from state to state). McMillan also undertook work to determine whether the judgement in <u>Parker v</u>

<u>Commonwealth</u>, thought to prevent military negligence actions against the Commonwealth, was likely to see the two 1980 actions fail.

In the first half of 1980 McMillan repeatedly sought a waiver of the stature of limitations so that suits on behalf of various parties (including, perhaps, McMinn) wouldn't be halted. He filed the initial writ on behalf of veteran Richard Brady and his family on 3 April 1980, when worried that their right to sue would be extinguished. With waiver matters still unresolved in early June, a further writ was lodged in Brisbane, this time on behalf of veteran Ken Fulton and his family. By initiating proceedings before the statute of limitations was thought to take effect, the right to proceed against the Commonwealth and chemical companies (many more of which were listed in the first writ than the second) was believed to have been preserved in each instance. McMillan also held discussions with the chemical company defendants in the second case, in an effort to streamline proceedings.

The US Class Action

The class action work undertaken by McMillan in the first half of 1980, was aimed at assembling a group of veterans to be 'representative' participants in the US proceedings and at securing the relevant US court's approval for that participation. State Branches of the Association performed an important support role: disseminating information, encouraging participation and gathering the inevitable forms, all in the hope of compensation for their members and hope of a persuasive outcome for use in other investigation and compensation activities.

McMillan acted quickly to familiarise himself with relevant US events, to brief McMinn (and presumably others) and then to get forms to State Branches for completion by veterans. Using the collected information, he had, before the end February, drafted and lodged in New York a lengthy 'verified complaint' and a litigation docket. That docket listed (as members of the class of plaintiffs) 40 living Australian veterans, a deceased veteran and that veteran's widow... but also mentioned children

at risk and children in generations to come. He

evidently established good relations with the Yannacone team while in the US and was assisted by (and in turn aided) the plaintiffs' consortium. In April he was back in the US, taking steps to establish the Australian veterans as a separate class before the court and to witness attempts (a) by the chemical company defendants to stymie the larger proceedings and (b) by the US Government to extricate itself from the case.

If the complexities of Australian litigation processes were such that Association officials, like most lay Australians in this period, were in no position to tell whether matters were being appropriately advanced in the two Australian negligence cases, things were worse with the (US) class action. There was no equivalent of the class action in Australian law at that time and the preliminary procedural matters which occupied McMillan at home and, especially in the US, must have seemed frustratingly mysterious (and unnecessarily slow) to the Association officials to whom he reported from time to time. McMillan's tendency while in the US to become involved in matters peripheral to the Australian element of the case - as was his right, providing the Australians weren't being billed for that work – probably

contributed to rising Association dissatisfaction with him, as did a perception

him, as did a perception that he was enjoying work in the US (and with the Americans) a little more than he should.

The Association officials' lack of control of class action matters, the delays in communications between Australia and the US, and the labyrinthine related litigation processes probably contributed to a deterioration of the

probably contributed to deterioration of the relationship between McMillan and the

Association in late May and early June. The sizeable fee to be taken by the Americans in the event of a win and McMinn/Victorian Branch dissatisfaction with legal matters being run from afar (from Queensland) doubtless also played a part, as did the inability of John Evans to have input to the US case preparations (except in writing). Perhaps there was a feeling, as well, that McMillan – who had also been representing the Atomic Veterans' Association – was spreading himself too thin.

The alleged failure of the class action documentation to comprehend Agent Blue (a Vietnam herbicide containing arsenic) brought matters to a head. According to McMillan, a group of officials (McMinn, Adams and Branch Presidents), sent him a telex threatening to withdraw from the class action, unless Agent Blue was

Diggers sue US firms

WESTBURY, New York, Tuesday (AAP-AP). — A class-action lawsuit claiming that more than 600 Australian servicemen were harmed by exposure to the herbicide Agent Orange in Vietnam was filed yesterday in the Federal District Court.

Mr William McMillan, of Brisbane, who appeared for the claimants said about 200 of them were already taking part in a suit by about 600 American servicemen against six chemical companies which had made Agent Orange.

But Mr McMillan said he decided "it was necessary to file a separate classaction suit" because "the number of Australian servicemen affected . . . proved to be disproportionate to the others".

He said he had obtained information from the Australian Government that the use of Agent Orange had been concentrated in Phuoc Thuy province, where the Australian thoops had been concentrated.

The suit named eight chemical companies as defendants. They are Dow Chemical Co, Monsanto Co, Hercules Inc, Thompson-Hayward Chemical Co, Shamrock Corp, William T. Thompson Inc, and Uniroyal Inc.

included. Association officials also seem to have refused his phone calls.

The ever-imperturbable McMillan, who'd dealt calmly with earlier annoyances, was clearly irritated by the Association's behaviour at this point. He persuasively refuted the assertions that Agent Blue had been omitted and provided a sensible way ahead for the aggrieved officials viz holding off on withdrawal until they'd received assurances from the US regarding the inclusion of Agent Blue. He even took steps to placate Evans. But at the mid-year point, Association confidence in him looked to be irreparable and continuing organisational support for the US proceedings seemed doubtful.

Coordination of Activities

Surviving materials don't reveal anything useful about the coordination of early Association activities. Indeed, it seems that in the absence of mechanisms for agreeing on policies and processes (aka a national constitution) and for coordinating activities, State Branches acted as independent entities. They mostly left Federal Government and parliamentary interactions to McMinn, and scientific commentary to Evans. The two things in the first half of 1980 that point to some measure of combined action (as distinct from collaboration on activities) were (a) the press release responding to Minister Adermann's 21 February statement (mentioned in the previous instalment in this series) and the mid-June telex sent by McMinn, Adams and Branch Presidents to McMillan threatening to withdraw from the class action.

As was noted in earlier articles, the technological advances that would make inter-state communication easier and cheaper in later decades didn't exist in the period covered here. Coordination and collaboration by phone would have been both ineffective and expensive (more about which below).

With air travel also being hugely expensive, face to face meetings were also impractical. There were meeting possibilities on the sidelines of other

planned gatherings, like the "national forum" announced by ACT Association Secretary, Mike Boland, in early February 1980, and a National General Meeting scheduled for 12 and 13 April, but there seem not be any records of these events taking place. Thus it was that, apart from any one-on-one phone conversations between Branch Presidents, or between individual Branch Presidents and McMinn, there weren't useful coordination opportunities – assuming the existence of any real willingness to cooperate – between the State visits made by McMinn in January/February 1980 and the national conference held in May 1980.

Minutes of that May conference, if they were written in Bill McMillan's (probable) absence, are not in any of the collections examined by the author and seem not to be in the possession of readers of earlier articles in this series. It isn't therefore clear what decisions were made about the ways in which things should proceed for the Association. Hints about the proceedings in documents about other matters do point, though, to attempts at the coordination of at least one set of common Branch activities viz the welfare ones. The appointment of a Victorian social welfare worker, Dirk Van Neuren, as National Welfare Co-ordinator points to a recognition that, in at least the provision of welfare services (if not the pursuit of related funding), collaboration was desired.

Strategy

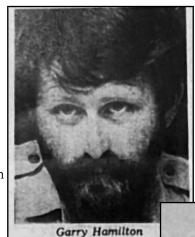
The Association's strategy in this period embodied the scattergun approach, rather than simple opportunism, with efforts being made to persuade the Government of the soundness of Evan's science, to pressure the same Government into permitting a public (judicial) inquiry, and to have DVA adopt a more accommodating approach to claims, including possible amendment to repatriation legislation to cover wives and children. There was a complex, seemingly unstated logic in play, justifying action on multiple fronts.

If the Association's take on the science was accepted by the Government, then repatriation claiming outcomes could be different, as a wider

range of disabilities could be accepted as warcaused. After changes to repatriation legislation, wives and children could also be compensated. The judicial inquiry could, if the Government again accepted the science, still explore the harms and make recommendations about supplementary compensation etc, having taken evidence from the veterans and allowed them to cross-examine witnesses.

If, though, the favourable science hadn't been accepted by the Government by the time any

judicial inquiry commenced its work, a proper hearing of the veterans scientific case would, it was thought, lead to acceptance of that science (with positive repatriation claiming and other compensation consequences).



Interactions with parliamentarians and the media (and through both with the public), and engagement with the legal system at home and abroad, served various and multiple components of the larger above-outlined strategy.

Funding

Funding had been a problem for the new
Association from the outset, and individuals
like McMinn and Evans, needing to travel in order
to represent the new organisation, didn't need to be
reminded by Bill McMillan in early February 1980
(see above) of the need for a reliable source of
funds beyond the relatively small sums raised
through membership fees (only required from
veterans able to pay). The capacity of McMinn and
other officials to engage, face-to-face, with
politicians, senior public servants, the RSL National
President and even Association State Branches was
limited by money at hand, mostly their own.

Even where State branches conducted dayto-day welfare activities from office-bearers' homes, relying on volunteer professionals and/or lay assistants to contain costs, there was a need for funds to meet various expenses. In branches where officials gave up employment to perform association activities there was doubtless a greater need for financial support, even if only to cover costs incurred in the additional welfare and promotional activities permitted by full-time effort. It was the need to self-fund work on behalf of the Association, and the decisions to forego income in order to perform that work (or, more accurately, 'the lack of peer acknowledgement of the consequent personal financial costs') that would be a major cause of disappointment and bitterness among early Association officials in later years.

Attempts were made in the first half of 1980 to combat the Association's funding judicial inquiry (see previous article) included a requirement that the Association's participation be

appropriately funded by the Federal Government – action for which McMinn said there was "vast precedent". That funding request was rejected, along with the judicial inquiry to which it was attached.

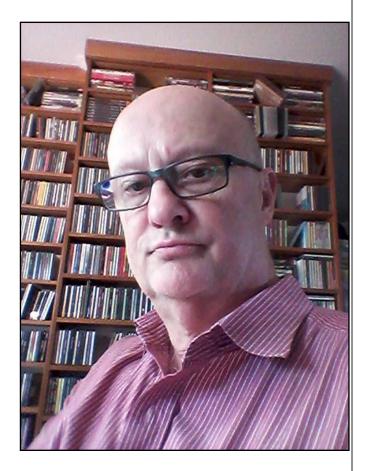
Other requests for Government financial assistance were for grants for welfare activities (but almost certainly providing for other activities/ personnel). These requests included a McMinn application to Minister Adermann for a grant-in-aid in late March 1980 (supported by correspondence from the Victorian Association President, Gary **Hamilton**) and the more practical grant approaches by the NSW Branch's Carla **McCallum** to NSW Government entities – the first being via Premier Wran in April 1980. (Both the McMinn and McCallum attempts are covered in detail in an earlier instalment in this series.) None of these applications met with success, even if they played an important role in emphasising the importance the Association attached to veteranconducted welfare activities.

The lack of cash not only stymied plans to upscale welfare services but must have signalled an end to other hopes eg for the part-payment of officials, the payment of honoraria to professional helpers and the acquisition of more suitable premises. The lack of funds almost certainly brought an unheralded end to a planned study tour of Vietnam and an associated fund-raising film.

Not all fund-raising efforts failed. Gary Adams, Secretary of the NSW Branch, who'd probably not improved the content of one of McCallum's grant applications, was especially adept at fundraising by direct approach to RSL Clubs and Sub-Branches. His admirable, unashamed soliciting for funds was combined with the educative work that he and Phil Thompson successfully did, commencing in the latter part of the period covered here. The sums raised, though helpful, can only have covered a few of the costs incurred by the two men in their various activities. Other branches of the Association employed the traditional money raising strategies of community organisations (as they would do for years to come) but subsisted in "smell of oily rag" fashion, apparently unable, even when willing, to finance activities beyond their own component of the organisation.

The next article in this series looks at the relevant activities of (and relations with) the RSL in the first half of 1980. It also attempts to piece together the story of early Branches of the Association in the same period.

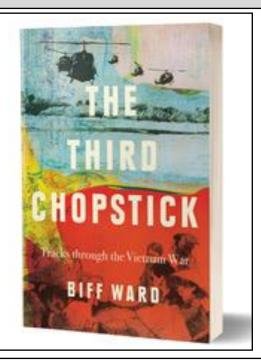

He contributed so much to our Federation and to veterans' welfare in general.

As I drifted about [at the Granville office], I saw that the volunteer advisors each had their own style, just as Ray had told me in Darling Harbour. One was quiet, focused on pen to paper, another joked and spread his hands. It was triage work. They listened and decided what was needed: accommodation, money, food, medical help. Nearly always, they set the guy on the path to repatriation benefits, which meant supplying contacts for psychiatrists. As volunteers, they worked as much as they wished, every day or once a month.

It's part of our own therapy, they all told me. We've been there.

As they helped each other wind down a little, it granted them enough slack to be able to help the next guy wind down too.

One guy said to me, they wound us up with all that training, but they didn't wind us down. They were working out how to do that themselves.

Memories of a Nasho - Part 4—The Final Chapters. Post Vietnam, the Downside and Upside

THE DOWNSIDE

"F---- off and don't tell anyone where you have been". These were the final words of advice that I was given as my two years of National Service came to an end. It was the time of protest against the Vietnam war and it seemed so unjust to be treated this way for not only my time in the service of my country but also for mates who had made the ultimate sacrifice.

So, like many Vietnam Vets, I just went underground. I got on with life and returned to outback western NSW and became a station manager of a very large sheep station near Wilcannia. I met the love of my life, a Sydney nurse and we were married in late 1971. Two children, both boys came along in 1973 and 1974 followed by an only and favourite daughter in 1979.

I suffered from the Agent Orange rash for many years and had bouts of wartime nightmares and malarial type sweating. In the middle of the night, my wife would not only have to calm me down but also change my pyjamas and the completely soaked bedsheets. Eventually, following a collapse, I was flown out by the Flying Doctor Service and diagnosed with malaria. I received a special course of tablets and was finally cured of the condition.

I had virtually no contact with anything to do with Vietnam until the "Welcome Home" parade in 1987. It was only through another Veteran and the urging of my wife that I attended that most wonderful event. My wife says that we were like kids at a birthday party as we met one and then another and then still another of our Vietnam mates. There were tears of joy and hugs and backslapping as we met up. It seemed a great release of all the bottled-up feelings and thoughts that we had harboured over the years.

Finally, it seemed that we were being accepted as true wartime veterans. During the march through the city, crowds of people lined the streets and waved banners of welcome and thanks.

At the concert in the domain, it poured with rain, but no one moved because we did not want to break the magic spell of our reunion.

Following that wonderful and momentous event, I attended our 9 RAR reunions in Adelaide, Perth, Brisbane, Canberra and Maroochydore. I was also at the dedication of the Vietnam War Memorial in Canberra and will never forget the low overflight of a lone Huey helicopter as it flew along the march to the memorial. The deep whop, whop, whop of its rotor blades brought back such strong memories of our time in Vietnam. A similar thing occurred at our reunion in Perth. We were assembled at the war memorial up in King's Park overlooking the Swan

River and the city. As the names of our war dead were being read out, three Caribou aircraft flew in-formation and low, right over the top of us assembled veterans.

It is my belief that those Vietnam veterans who have been involved in reunions and meets are in a better frame of mind and have handled life better than those who have remained underground. I have also been most fortunate to have a wonderful wife who has

not only shared the better times but also supported me through the low periods of my life.

In the mid 1990's, I experienced my worst time when I started getting flashbacks of horrific wartime scenes of my time in Vietnam. I turned to Dr Bundaberg Rum to ease the pain and things spiralled down. Fortunately, my Vietnam mates helped me to register with DVA and I was called for a medical review. Following that review, I received a white card for PTSD, hearing loss and a couple of other matters. The greatest help that I received however, was being referred to a psychiatrist, Dr Jim Taylor. He helped wean me off Dr Bundaberg and get those terrible flashback images out of my memory in the back corners of my brain. I also had a paranoia of crowds and used to get panic attacks when in such a situation. Dr Taylor retired some years ago and referred me onto another Doctor who I still see a couple of times each year. My fear of crowds still remains.

However, I am able to manage my feelings reasonably well. My wife shared this very low period of my life. Whilst initially fearful of my sessions with Dr Taylor, she now agrees that it was the best thing to happen to me.

At a local Anzac Day commemoration, I was asked to be the guest speaker. I would like to quote two sections of my speech which you may find interesting and contra.

"I have to say, that like many before me, I found it all a great adventure. We were young and strong and fit with a whole lot of other young blokes. The girls were all beautiful and the music of the 1960's

> was truly fabulous. It was a great time to be alive. We were jumping in and out of helicopters and flying in various other aircraft. We were training with and firing all sorts of machine guns and other weapons. We went on training exercises up in the remote Blue Mountains of NSW and in the McPherson Ranges along the NSW/QLD border above the Canungra Jungle Training Centre and in north QLD. We travelled in Armoured Personnel Carriers and worked

with huge Centurion tanks. Even going overseas to Vietnam seemed somehow exciting and exotic".

And another part of my speech –

"Finally, I would like to speak about those brave men and women who served. In my own case, 35 men from my unit, of the 523, were killed in action in Vietnam. 35 good men, boys really, who were not able to go on to marry their sweethearts and have children or experience the wonderful joy of grandchildren. The effect on their families is still being felt today over 50 years since they were killed. Many of the men in my unit were wounded in action and all were psychologically wounded in some form or other from the horrors they experienced.

When I read and hear about

how veterans of conflicts since

Vietnam are still being treated

Affairs, it makes me angry to

know that so many of those

veterans are being treated so

by the Department of Veterans'

Tragically, when we arrived home, our own society rejected us and labelled us baby killers and some even had red paint thrown over them. Many were further traumatised by this rejection and went underground and dropped out of the world".

I have been so fortunate to have such a supportive wife. At times it must have been so unbearable for her when I pushed her away – "You don't understand because you were not there". She held me through my nightmares and comforted me when I was at my lowest. When I was attempting to upgrade my status level with DVA, she insisted on being with me at the interview. When I was being questioned about various conditions and answered that things were not too bad and that I was handling things reasonably well, her reaction to the interviewer was "That is NOT right, he is really struggling because I know,

I have to care for him". The pension officer immediately sat up and said to her – "Tell me more".

It was really because of my wife that I finally received a DVA Gold Card in 2009 and all of my conditions were accepted as being caused by my service in Vietnam as an Infantry soldier/signaller. I have to sincerely thank

Denis Hamner (OAM) from the Vietnam Veterans Federation at Granville for doing the hard yards and preparing all the paperwork for me. Without his help and my wife's determination, I may have not achieved my upgraded status.

badly.

When I read and hear about how veterans of conflicts since Vietnam are still being treated by the Department of Veterans' Affairs, it makes me angry to know that so many of those veterans are being treated so badly. Tragically because of the long delays in having their cases being dealt with, so many veterans have taken their own life. It seems that the latest scam by the Department is to simply allocate the tens of thousands of claims that have been made and then release statements that the backlog of claims has been dramatically reduced. These veterans may have to wait a year or more for

their claim to be accepted. But, they need the help now – not in a year or two's time. I hope and pray that the Department of Veterans' Affairs can address all the claims by veterans in a timely manner.

Our politicians send off our servicemen and women into harm's way with their hands on their hearts promising to look after them and their families if they are wounded or killed. Now, all we demand is that they honour that promise!!!

THE UPSIDE

"This man has leadership potential" were words written by my Infantry Corps training Platoon Commander. These words were quite uncanny because they proved to be a major factor which

> governed my life post National Service.

I have written in my previous chapter— the Downside" of the effects on my life caused by my service in Vietnam. However, it almost seems that I have lived another life in parallel with that downside.

There is no doubt that my time in the army subtly developed various skills and in particular leadership skills. Leadership is not about being bossy or ordering people about or letting them know that you are in charge. It is basically about recognising the skills and talents of people in your team and then providing the conditions for those talents and skills to develop and blossom. It is about supporting the people in your team and not micro-managing them.

Before all operations in Vietnam, we received a briefing. Each man knew his own role and what was required of him. He also knew what each man in his section's role was, so that if that man was killed or wounded, another could step in and fill that role. The briefing was and is a very important part of any task and was part of my learning process.

The first opportunity for those skills that were developed by my time in the army came about during the massive bushfires that occurred in the western division of NSW in the summer of 1974/75. There was no leadership in the field and in frustration, a group of us farmers agreed that something needed to be done. They urged me to take on the position of Bushfire Brigade Captain because, "You have been in the army and know how to organise things". And, that is where it all started. I did take on the position of Brigade Captain and was able to successfully conduct bushfire fighting operations. Because of that success, I was appointed by the NSW Government as an "Emergency Fire Controller" in charge of a series of very large bushfires. Following another very bad series of bushfires during the summer of 1976/77, I was appointed as a Group Captain in charge of firefighting operations in the largest Shire in NSW, an area the size of Tasmania.

Over the period of my time in the far west, I was called on to manage and control hundreds of bushfires with about a quarter of them being major operations. These major bushfires can be hundreds of kilometres in circumference. They require very extensive management and logistics in manpower, earthmoving equipment, fuel and food resupply, mechanical and tyre repair and safe operations. Because of my experience in bushfire control and logistics, I was invited to become a member of the Bushfire Council of NSW and was elected as Chairman of the Technical Sub-Committee. In 2008, I was awarded the Australian Fire Services Medal in recognition of my services.

As Bushfire Brigade Captain, I had established not only Bushfire Brigade units in the pastoral areas of my Shire of Central Darling but also a town brigade in Wilcannia. In 1982, there was a tragic road accident on the Barrier Highway in our area. People were trapped in vehicles and some actually died because there was no rescue squad with suitable equipment to release them. The local Police Sergeant approached me to establish a rescue squad in Wilcannia. After calling a town meeting and further investigation, I was able to establish a State Emergency Services road rescue unit and thus began my involvement with the NSW State Emergency Services. They provided a basic road rescue kit and trailer. I joined the SES and was appointed as a squad captain. The SES also provided training in not only road rescue, but also over a period, in navigation, flood-boat operations, rescue from heights and depths, chainsaw operations and training.

Whilst road rescue was the main operational task for my SES unit, we had a number of successful search operations for lost persons including two very young children that had wandered away and were out overnight. We also had mine rescue training at White Cliffs and for a natural gas pipeline explosion. Over the years, my unit attended a large number of road accidents which often involved not only freeing trapped and injured persons but also in recovering the bodies of those killed in the accident.

My leadership skills in the State Emergency Services were recognised and I was appointed as Local Controller for the Shire of Central Darling. In the late 1990's, I was awarded the NSW State Emergency Services medal by the Minister for Emergency Services.

In 1982, I was approached by a number of people to stand as a candidate for our local Council elections and agreed to do so. Following the ballot, I was elected as a Councillor in A Riding which took in my property and the towns of Wilcannia and White Cliffs. Our Shire of Central Darling only had 3,400 residents in the entire Shire. We had an area of some 51,000 sq kms and there were three major towns of Wilcannia, Ivanhoe and Menindee, the village of White Cliffs and two hamlets Tilpa and Darnick.

Our rate-base only contributed a small amount but, we had contracts with the NSW and Federal

Governments which enabled us to maintain a workforce in each of our major communities.

I was on the Council for sixteen years over four terms. In my third term as Councillor, I was elected to be Deputy Shire President and in my final term, I was elected Shire President which is equivalent of Mayor.

There were other appointments over the years because of my leadership skills. I was appointed by the NSW Government to a number of posts. I was a member of the Wild Dog Destruction Board which operates and maintains the wild dog border fence between NSW and South Australia and NSW and Queensland. I was on that board for 21 years. I was appointed by the NSW Government as a Land Board member. The Land Board is like a Court that hears and makes determinations on matters to do with local land disputes and boundary issues as well as advising Council on land use matters. I was on that board for over 20 years.

I was elected President of our local NSW Farmers Association and its predecessor the Livestock and Grain Producers Association. There were other groups that I was associated with including being Secretary of the Wilcannia RSL Sub-Branch for 35 years and a further number of years, Secretary of the Narromine RSL Sub-Branch.

However, perhaps one of my prouder associations was with my local aboriginal community. As landholders, my wife and I made available our property for visits by them in various ways. We had an aboriginal sacred site on our property and were able to negotiate access to that site by local aboriginal people. We gave free access to aboriginal work parties cutting and gathering firewood for the older members of our community. We encouraged and fostered Boys camps where aboriginal elder men would bring out boys to pass on their cultural stories and values. We were able to supply freshwater and bushtucker on a suitable site along the river. We also conducted Girls camps for the older aboriginal women to bring out and teach young girls about female matters and values.

As a Shire Councillor, I was always proud of the fact that our Shire employed a good number of aboriginal people. However, it was as Shire President that I discovered that many of our aboriginal employees were struggling with literacy.

Realising the problem, I was able to arrange literacy classes to be done in Shire time and also arranged for medical and dental checks too. The results were very pleasing with a lift in satisfaction amongst our employees.

In 2004, I received the Anzac of the Year award for services to the community. The award consists of a large heavy pure copper medallion featuring John Simson and his donkey on the front side and is engraved with my name on the reverse side. Ater the Combat badge and the return from Active Service badge, this is the award that I treasure most. A maximum of only one award per State can be made each year and in 2004 only four awards for the whole of Australia were made. My nomination was made by the State Emergency Services Commissioner, Brigadier Phillip McManara and seconded by my Vietnam Company Commander, Brigadier Laurie Lewis.

In 2005, at the urging of some fellow veterans, I joined Legacy and became a Legatee. I became quite actively involved when a very young mother's husband passed away from a condition exasperated by his service in the Solomon Island Peace Keeping Force. She had two children aged two and five years. I was her Legatee and my wife and I were able to assist her in attending a number of Legacy camps. Our branch was able to assist this young mother establish a new life although there were many difficulties along the way. Her children are now 17 and 14 years old and happily she married a widower with three boys of his own.

In 2010, I received an Order of Australia medal also for services to the community in recognition of my involvement in all of the various groups and organisations over the years.

I am sure that the organisational and leadership skills that I absorbed whilst serving in the army and particularly in Vietnam had a major influence on my life. In a remote community like Wilcannia, those skills became a major asset to that community and the people of the far west.

SIDE HUSTLE

TAX AND YOUR ON-LINE

With money becoming tighter as inflation rises, many people are looking to make some extra income from a 'side hustle'.

As we move towards a cashless society and transact more online, it's becoming easier for the ATO to follow the money trail. Whether you rent your caravan on Camplify, or even if you simply sell household items on Gumtree, the tax man will be paying attention.

Not all online income needs to be declared, but it's important to understand the difference between an online hobby and a business. Otherwise, you could find yourself with an unexpected tax bill.

Business or a hobby?

Even with a well-paying day job, many people have an online side hustle for fun or to earn extra cash.

Whether your online activity is just a hobby or a business makes a big difference.

Income earned from hobby activities is non-assessable for tax purposes, while income from a business is assessable and must be declared in your tax return. This could include revenue from an eBay shop, rental income through platforms such as Stayz, and fees from work sourced from Airtasker.

There is no legislative definition of 'carrying on a business', but the ATO provides a series of questions to help you decide. For example:

- Do you have an online 'shop' and pay fees?
- Is your main intention to make a profit?

- Do you make regular sales?
- Do you manage your online sales activities as if they are a business?
- Do you advertise your online space?
- Do you keep records and have a business plan?

Every 'yes' means you are more likely to be carrying on a business.

Side businesses and tax

Where your side activities are a business, you must declare all your secondary income, regardless of how much or how little you make each year.

If your side hustle is considered a business for tax purposes, it means your business-related costs are tax-deductible and you may be able to access the various business tax concessions on offer.

For side businesses where your annual turnover exceeds \$75,000, you need to register for GST. This tax needs to be added to all your taxable sales and paid to the ATO every quarter.

With online activities that remain a hobby the income is non-assessable and you do not have compliance obligations, but you can't claim a deduction for your costs.

ATO surveillance and data-matching

Although some taxpayers think their online hustle will go unnoticed, the ATO has vast datamatching powers to help it identify any unreported income – wherever it is earned.

In recent years the tax regulator has made it clear online-generated revenue is an important target for its non-compliance surveillance activities.

The ATO receives and collates information from a wide range of third-party sources, including banks, payment systems and online selling platform providers such as eBay, Amazon Commercial Services, Airbnb and Uber.

The ATO also has the power to collect information for its data-matching projects to address concerns about specific industries, issues or tax risks, and one of its 'special purpose acquisition data' programs covers online selling.

Under its online selling data-matching program, the ATO tracks the activity of registered online sellers and obtains details of businesses with annual trading activity in goods and services of \$12,000 or more.

Get professional assistance

If your side hustle is successful and becomes more than a spare time activity, it makes sense to talk to an accounting professional. They can help you decide whether your activities will be considered a hobby or a business.

A business must substantiate any tax deductions it claims, so you need to keep detailed records of all your business-related activities and ensure you lodge your business activity statements (BAS) and tax returns.

We can also help you work through your tax obligations such as applying for an ABN, registering for GST, and establishing a proper recordkeeping system for your income and expenses. You may also need help with preparing and lodging your quarterly BAS.

A SHORT HISTORY OF THE RAAF IN VIETNAM

The involvement by the RAAF in Vietnam started with arrival of the training team when Dakota aircraft from Butterworth Malaysia provided a resupply service to the members of the Australian Army Training Team Vietnam not only in Saigon but at more remote airstrips where the team were operating with native troops.

In August 1964 three aircraft on their delivery flights from De-Haviland Canada were diverted from Malaysia to Vung Tau in South Vietnam where they commenced operations the next day. They were known as Wallaby Airlines not because of the red kangaroo on the aircraft but rather the squadron call sign of "Wallaby". Another aircraft was added, and this became RAAF Transport Flight Vietnam. Later another three aircraft were sent to Vietnam and the transport flight became 35 SQN.

The Caribou was a short take-off and landing aircraft which could utilize the dirt and basic surfaced airstrips throughout the area of operations. The Caribou operated with a crew of four being 2 pilots, a loadmaster and assistant loadmaster carrying anything that would fit into the cargo bay.

Ther were 3 aircraft lost during the deployment with no major casualties.

Mail, ammunition, passengers, fuel, timber and even live animals were transported in the caribous. The Caribous were the first in and last out leaving Vietnam in February 1972.



UH-1 Iroquois

With the increase in ground troops and the formation of the task force in 1966 the RAAF decided to deploy 9 Squadron, flying UH1 Iroquois helicopters. After some disagreement with army about being too far away from the task force the helicopters were co-located with the Caribous at

Vung Tau. The need to service aircraft during night -time under lights did not go down well with the army brass as a blackout situation was in place at Nui Dat. Iroquois helicopters played a major role in the battle of Long Tan when two aircraft flew through heavy rain with landing lights blazing to resupply D coy 6RAR with ammunition. The Iroquois left Vietnam with the task force in December 1971.

On 19 April 1967, the RAAF stationed a squadron of English Electric Canberra Bombers at

Phan Rang on the central coastal area of Vietnam. The Canberra was developed during the 1950s as a high-altitude precision bomber but adapted to the role of a low level or medium level bomber with ease when flown by the Australian crews of 2 Squadron. 2 Sqn were credited with 5% of the total bombing effort during its stay and 16% of the bomb damage. The sqn was awarded the Presidential Citation by both the USA and the Government of South Vietnam. There were two aircraft lost with two aircrew being killed. Magpie 91 (magpie being the callsign of 2SQN) was lost during operations on 3 November 1970 and not found until February 2009. The pilot and navigator Michael Herbert and Robert Carver were recovered, and finally brought back to Australia thus completing the recovery of all our fighting force. The second aircraft was shot down by a missile and

the crew successfully parachuted out and were recovered by helicopter very quickly. 2SQN departed Vietnam 4 June 1971 thus being last in and first out of Vietnam.

The story of the RAAF in the Vietnam war is not readily known as it did not make the headlines with big battles against the enemy or capture weapons or prisoners or other newsworthy stories. The RAAF was an all-volunteer force, professional and got on with the job in a quiet and efficient manner.

The RAAF was back in action in Vietnam again in April 1975 recovering the embassy staff, refugees, and babies from the orphanages to be flown back to Malaysia. The last flight out of Tan Son Nute was to pick up the RAAF guard who had to be left behind as previous aircraft were full. The mission was flown by a C130 and at considerable risk as enemy forces had at that time surrounded Saigon. RAAF squadrons had a higher serviceability rate than any other service in Vietnam and the methods of delivering stores was eventually copied by others as it proved the safest and most proficient. I was a member of that force between 1967 and 1968 where the effort to control the land was at its highest. The RAAF assisted the task force whenever requested and can include all the major actions including Long Tan and Balmoral/Coral as battle honours.

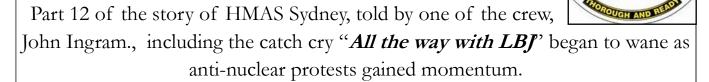

HMAS SYDNEY:

The bloody "American War" 1966-67



Up until the TET (Viet New Year) Offensive in February, 1968, Australians were, in general, supportive of our nation's involvement to contain what was known as the "domino" theory of progressive collapse of Asian democracies to communist regimes. President Johnson and his military chiefs had tried to convince Allied forces the war was proceeding well etc while the steady build-up of forces and combat continued. However, "embedded" war correspondents were telling a very different story illustrated so convincingly on the TV news, day in/day out.

The catchery "All the way with LBJ" began to have a hollow core as the global peace movement, conceived in the Anti-Nuclear War movement, gathered strength. The "Flower power" movement soon crossed the Pacific and anti-war rallies became common in such hot beds of discontent as university campuses, even at the gates of military bases including Garden Island and Cowper Wharf Road. When SYDNEY was alongside in her home port her presence was marked by unruly demonstrations, often restricting movement of naval personnel and vehicles. We were instructed not to wear uniform ashore lest we be sworn at or abused, even spat upon. The Navy urged us to delist home phone numbers from directories to avoid intimidating phone calls.

In war awful things happen; one incident in particular I witnessed was especially violent. SYDNEY was moored off Vung Tau on a typically hot, steamy day. I was on the flight deck taking in a few gulps of fresh air when a vintage USN "Fram 2" destroyer steamed by on picket duties. Her turrets were rotating as she closed in on a fishing boat maybe 15 metres in length. I could see small children playing midships on the nondescript vessel as it motored along seemingly and innocently going about its business. When around a mile distant the destroyer pulled away from the track of the fishing boat and at some 200 metres fired a shell into the wooden boat blowing it to smithereens. It seemed a senseless act of destruction. I've no idea whether the occupants were removed from their floating home beforehand. It was definitely not the way to win the hearts and minds of people. Violence begets violence and so the cycle continues. I often recall that cruel incident. An orange and black fireball, then flotsam on the murky waters.

Now for matters of a lighter nature involving money. Very significant amounts of Australian and select foreign currencies were carried to pay sailors and soldiers their salaries and allowances and reimburse for expenses incurred. Cash was also required to pay traders while a huge, arcane

"chequebook" measuring some 600mm by 300mm was carried to pay the really big bills overseas. This heavily scrolled "Bills of Exchange" written in a flowery language were a leftover from the Victorian era and designed to impress the unfortunate and confused recipient "the Bearer, on behalf of Her Britannic Majesty and the Government of Australia, promises to pay"

I tried to use one once to pay a trader for fresh provisions delivered ship-side. The Trader took one look at this monstrous cheque, had absolutely no idea what to do with it, then suggested he reduce the debt to the Australian government to a level within my authority to pay. This saving involved thousands of dollars at what was roughly a 50% discount. We all dined well on fresh tropical fruits and vegetables for the next 21 days! However, revenge for him was sweet in that his produce hadn't been treated for cockroach infestation. Upon the ship's return to Sydney, we had to have the entire ship fumigated to kill the pests.

Following an armed robbery involving a cash delivery to warships at Cockatoo Island we in the SYDNEY were directed to ensure our money safes were securely mounted. We had two, one being of bank vault size and possibly weighing two tonnes abutting the Captain's Day cabin. It contained bulk bank notes and was only accessed weekly whereas the "ready use" safe was opened many times daily and commonly contained up to \$250,000. It was located in the Accounts Office. I arranged for a Shipwright to check the installation and within a matter of minutes he, with a single spanner, had removed the entire safe from the steel bulkhead. This safe had been positioned there 20 years previous with the nuts to the four bolts protruding into an insecure space. The safe, along with its significant monetary contents, could've been removed from the ship by two men with evil intent. It was an amazing design oversight.

On one return passage from South Vietnam to

Sydney I had in my official possession used Australian bank notes and coins worth in excess of one million pounds. This very significant sum was being repatriated from Singapore and Malaysia where it had accumulated in branches of the Commonwealth Bank. For security reasons only three persons on board new of this repatriation of currency concurrent with the changeover to decimal currency in February 1966. At the time that was a lot of dosh and I was relieved to hand over to Bank officials on arrival in Sydney.

Also embarked was 5 RAR plus all of their equipment after completing a one-year tour of duty. These 600 men had to be paid their accrued pay in cash before arrival in Sydney. This required \$1,000,000 to be embarked via a clandestine operation. When the SYDNEY was off Moreton Bay a Wessex "chopper" was despatched pre-dawn to Eagle Farm Airport in Brisbane. Not even the three-man crew knew the nature of the operation such was the secrecy involved. In a James Bond-like adventure the aircrew were told they'd be met by a civilian with his personal trunk and to return to the SYDNEY pronto. I greeted the Treasury official on the windy flight deck and the Wessex was "struck down" below by lift into "C" hangar.

In the meantime, I'd taken the somewhat overawed Treasury civilian to the wardroom for breakfast. On completion he enquired where was his trunk? In the early morning excitement, we'd forgotten about his "personal trunk". No, it was not in the chopper, nor could we find it in the packed hangar spaces. Nor could we make an announcement over the ship's broadcast. Imagine his relief when we sited the trunk abandoned on the flight deck aft with its contents safely intact! It was then placed under armed guard in the Accounts Office until distributed by Army personnel to their grateful recipients the following day.

Earlier I made mention of the Cargo Plan. No SYDNEY officers had experience with the

preparation of such a plan. The RAN had access to a number of qualified merchant marine officers and these proved invaluable. The ones we had in my time 1965-67 were members of the Reserve Executive branch, held Bridge Watchkeeping Certificates and therefore qualified to exercise command both in harbour and at sea.

One such officer, British born, was the "Cargo Officer" and proved to be an interesting character. A raconteur and "actor" he could tell tales rivalling those of Lawrence of Arabia. On our second deployment he managed to fly by QANTAS to Saigon joining the ship off Vung Tau. Officers were mustered in the Wardroom Mess to be briefed by him on the dis-embarkation plan for which he was responsible. In swaggered our Cargo Officer dressed in US combat fatigues with a revolver and ammunition belt slung around his middling girth. Not a straight face as we viewed this comical "Walter Mitty-like" war hero.

To add insult to injury his plan didn't go well as the US military and their civil

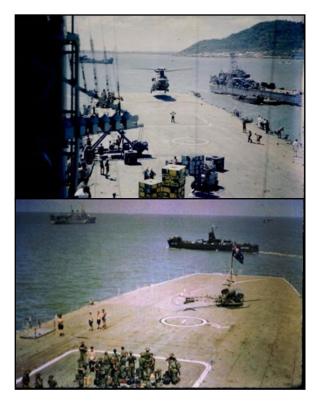
contractors were late in arrival with their "choppers", lighters and barges. One massive contract lighter was eventually positioned alongside by two tugs complete with a large front-end loader at one corner. Before it could be secured in the middle of the platform the lighter tipped causing the loader to settle on the very muddy harbour bed (from which it was eventually recovered).

Never camera shy and keen to publicise "his" war, our intrepid Cargo Officer sought aviation wrecks on the basis such items would prove valuable training aids at the Naval Air Station, HMAS ALBATROSS. The US Military had no shortage of wrecks and were willing to oblige. We embarked the bullet riddled carcass of a Huey-1B, which eventually found its way to the AWM in Canberra. But only after our "war hero" was photographed by the national media sitting at the shattered controls after our return to Sydney.

Many ships in the RAN in the 1960s had RN (Royal Navy) officers in their complements either on loan or exchange. We wore identical uniforms, served the same monarch and followed the same rules, disciplines and customs. In the SYDNEY we had RN personnel including our Gunnery Officer and the Captain's Secretary. But then the legal fraternity in Canberra started asking questions, induced by the fact Britain was a signatory to the five-nation council established by the UN to negotiate a peaceful resolution to the Vietnam War. Clearly it was not a "good look" having Britons engaged in hostilities in Vietnam. That meant RN officers were no longer posted to RAN ships deployed to Vietnam.

It was also deemed necessary to change the RAN ensign. In October 1967 the British White Ensign, so proudly flown by RAN ships since 1911, was replaced by the Australian White Ensign which incorporates the Southern Cross. A minor but visually significant matter.

Much has been said since the end of Australia's involvement in the Vietnam War in relation to 'public perception' and how veterans were treated upon our return home. There's no simple, "one size fits all" answer of course. As a nation we were "war weary" and tired of the media coverage of the incessant battles, casualties and destruction. The fact we'd been on the losing side meant politicians were only too eager to wash their hands of the whole, sad saga. National Service was "on the nose" and quickly abandoned so the Army could return to an "all-volunteer" service.

One of the few organisations which actually formally acknowledged our involvement in Vietnam was the City of Sydney which arranged for a march by returning Defence Force personnel through city streets, including the salute to dignitaries assembled on the steps of the Town Hall. I had the privilege of leading the SYDNEY contingent: a distinct honour.

Within the ADF senior management structure there was conflict and inconsistency. I cite some examples of mal-administration which caused all kinds of issues.

In the case of "honours and awards" naval personnel who'd served in the SYDNEY and her escorts were denied the Active Service Medal (Vietnam clasp), as well as any medal/s specifically related to service ashore in Vietnam or in designated waters (known commonly as the "Gun Line"). Even the City of Sydney acknowledged this gross anomaly and had minted a ribbon and medal which, of course, was not officially sanctioned by the Defence Department. Years later and after much public agitation the ADF, DVA and the government agreed to the award of the Vietnam Logistic Support Medal which was little more than a compromise, a grudging public recognition of our service. Decades

later and after further political arm-bending, we were awarded the Active Service Medal (Vietnam clasp) to complement the Vietnam Logistics and Support Medal. By then so many rightful recipients were either dead or so angry at the Government and ADF they refused to wear them.

- Another anomaly which applied right up until the First Iraq war, I believe, involved "pay and conditions of service". In both the Malaysian Confrontation and Vietnam War RAN personnel weren't eligible for any tax relief for prolonged periods overseas on "operational" service, when deployed to the Strategic Reserve or ANZUK forces for peace-keeping duties. In fact, when in harbour such as Hong Kong, Penang or Subic Bay during operational, official or recreational visits sailors were paid 50 cents per day allowance extra as "In Port Allowance". This meant sailors were paid marginally more to be in a safe harbour than in a combat zone! Try explaining that logic to entitled sailors, yet that was an example of the remuneration nonsense that applied at the time. 55 years after the formation of the RAN in 1911 the Navy was still operating under a "pay bible" titled "Interim" Pay Instructions or IPIs for short.
- what lay behind this Government inaction and delay was the potential cost to the "public purse". By denying naval personnel their rightful recognition would preclude medical coverage for illnesses attributed to or aggravated by "operational" or "warlike" service. The big unknown was the future impact of serious and/or potential terminal illnesses caused by "Agent Orange" and asbestos, the dreaded mesothelioma. Hence DVA fought for decades, not for the naval veteran, but to deny or delay treatment and disability support, whenever and wherever

possible.

In my case as a serving officer, I held a mistaken belief DVA was there to support the veteran with any health issues service caused or aggravated. I was soon to learn, along with all other entitled veterans, we had two opponents, one in Vietnam and the other, DVA.

I served under two exceptional commanding officers in the SYDNEY, namely Captain Tony Synnot (1965-66), later to become Admiral Sir Anthony Monckton Synnot KBE AO Chief of the Defence Force and his successor, Captain Eric John Peel DSC, in 1967. I especially appreciated their "inner peace" as leaders, the diction and clarity of their voices, irrespective of whether discussing a matter with you as an individual or addressing the entire ship's company. Their very presence commanded respect; both made you feel giving your best willingly was the natural course of action.

I cite two examples:

Following SYDNEY's mooring off Vung Tau on Captain Synnot's first deployment he was briefed by the OIC of a small US Marine Corps Armed Junk squadron of locally requisitioned fishing boats tasked to provide harbour protection. I was called to the Bridge and out of earshot of other personnel introduced by the Captain to the Marine lieutenant. Captain Synnot advised I'd be the "liaison" officer to work with this USMC unit to enhance the safety of SYDNEY and escorts whenever in harbour. I had no idea what this role entailed or when my already extensive departmental and watchkeeping duties would permit. I could sense with so much happening elsewhere in and around the ship the captain just wanted me to show initiative and not delay him any longer. His concluding words were that discretion and secrecy were expected and this "conversation" had not occurred. In other words, I was on my own. Just (Continued on page 51)

get on with it!

That "initiative" required developing a working "relationship" with this unit, their then primitive riverine patrol craft and personnel. Whenever an opportunity arose, I'd take ashore with me fresh loaves of bread and bread rolls stuffed into a carryall bag along with 6-12 bottles of VB beer (at my expense I hasten to add). These items were universally popular with both the USMC officers who commanded these small craft and their North Vietnamese crew members. Each time in harbour I'd re-acquaint with these personnel and do at least one day or night patrol (4-6 hours) in the open bay and into streams and rivulets. My RAN tropical uniforms of white shorts and shirt were totally inappropriate, so I'd need to change into US combat fatigues with black beret. Had I been captured explaining this clobber may well have been difficult but for me white uniform was a target all too tempting for sniper fire.

Each vessel was of timber and the engine a Chrysler diesel fitted midships around which was a deck-house in which the crew would sleep and eat. They wore the traditional "black pyjamas". To demonstrate loyalty to the South regime each had tattooed over their hearts "Hate Communists". This meant if caught by either the NVA or VC their heart would be gauged out while alive. These men, six to each boat, would man the 50-mm single canon in the bows and the 20 mm in the stern. There was no shielding or protection, just the wooden hull. Later in the war, purpose-built patrol craft were supplied but not in my time. Each vessel was skippered by a junior USMC officer and communication was maintained by a basic portable radio, rarely used as communications were known to be intercepted by the enemy. In the photo above a sailor is seen removing one of these portable radios lest it be stolen from the boat and used by the VC/NVA.

At night, irrespective of whether in harbour or on patrol, "off duty" Viet sailors would sleep in a lump in the deckhouse, lying across one another. This alarmed me initially as it appeared to my Western mind to have sexual connotations. Then it dawned, it was simply their way of keeping warm. Well, partly true: the real reason I soon learned was if one was disturbed for some reason, all immediately attended to their duties.

Beer was the international currency: Vietnamese love their beer. But one had to exercise caution and impose a limit of one 375ml bottle to two men on completion of a patrol. Warm beer, tired bodies and the need to maintain alertness were not compatible. I retain visions of these young men removing the metal cap with their teeth. The warm beer would have them chattering and laughing and releasing pent-up tensions.

One dawn we investigated a water front village near Vung Tau following reports of gunfire and

explosions overnight. We cautiously approached in the still air and eerie silence; wisps of smoke filtering through the vegetation. No dogs barking, no roosters crowing or kids playing at the water's edge. The crew, with both cannons manned, were visibly agitated, sensing an ambush. As we neared the shoreline the ash of several burnt-out dwellings came into view; a dead animal in the muddy embankment: no sign whatsoever of any inhabitants. Had they fled, what had transpired? Should we go ashore and investigate?

Curiosity needs to be measured. The sailors were keen to assist these village people; fellow Catholics who'd fled the Communist North. I felt a great deal of relief when the skipper decided it was too dangerous to land: wire booby traps would've been laid he surmised and, in any case, there was no sign of human life. Later we learned not a single villager or animal had survived the brutal attack, attributed to local VC supporters. All had been shot or hacked to death and efforts made to incinerate evidence.

It appeared to me to be a localised dispute that had got out of hand as neighbouring villagers resented the resettlement of Catholic northerners on their traditional land. Nevertheless, it was a chilling reminder Australia had also invaded their country as part of the Allied Anti-Communist cause.

We seek your assistance in reporting the death of Vietnam Veterans, past or recent, to allow the Federation to expand and preserve it's record base.

Kindly circulate a copy of this page through your RSL Club, Unit or Corps reunions and meetings and raise it as an issue. The information gained from these reports will greatly assist all Vietnam Veterans and their families regarding future claims for benefits.

YOUR MEDICO AND THE GOLD CARD

Recently, there have been media reports regarding General Practitioners and Medical Specialists rejecting the Gold Card for treatment, or charging a Gap Fee.

If a doctor accepts the Gold Card they cannot then charge a Gap Fee. If a doctor states up front before accepting the Gold Card that there is a Gap Fee payment, please advise the doctor you are notifying DVA, who will discuss the matter with the doctor in question. DVA may then refer you to treating specialists that will treat you under their system.

There has been a lot of confusion lately over the 12 visits to specialty trearment. There is a 12 visit or 12 months, whichever comes first before you have to report back to your Doctor, whereby he/she can prescribe another 12 visits.

VETERANS AND COMPENSATION ADVOCATES TIPS

- If a veteran has a Defence Service Home Loan, and dies before it is paid out, the loan is not automatically paid out. In some cases the loan may not even continue for the benefit of the partner. Please check with Defence Service Homes on Freecall 1800 722 000 to clarify your position.
- If on a DVA pension and travelling overseas it is necessary to notify the Department in plenty of time prior to departure. If you have a treatment card (white or gold) you also need to ascertain the treatments for which you will be covered, and how to access them.
- If a partner of a veteran who receives the Special Rate becomes widowed before they are 56, they will not be eligible for the Income Support Supplement. They may become eligible on their 56th birthday.

All veterans still in the paid workforce should be encouraged to contact a qualified compensation advocate prior to accepting any inducement to finish work, regardless of how generous it may seem, or what your health status appears at the time.

AVOID PUBLIC WIFI WHEREVER POSSIBLE

Public WiFi usually isn't as secure as a private network. If you do need to use it:

- Avoid online banking or shopping
- Never save passwords or leave your accounts logged in
- Switch off your device's ability to auto-connect to public WiFi
- Stay aware of your surroundings.

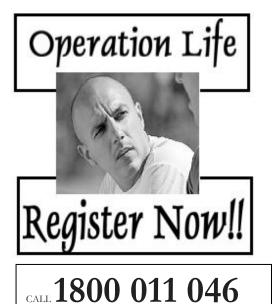
Yet we still receive veterans unaware of their rights, what they may be entitled to, and where and how to apply or enter a claim.
